Pictures of both courses available on PPFDC.com. 1-1/2 hours from Colorado Springs. From 1-25 in Colorado Springs exit Hwy 24 West. Take Hwy 24 west to Florissant. Turn left on Teller 1. At Llama Farm turn right on Teller 11, at dead end turn right on Teller 112 (to Guffey). Cross into Park County and turn right on Park 71. Go 0.5 miles to Doe Valley Road and turn right. Second driveway on left is the Doe Valley Course. Sky High Ranch is 5 miles further down Doe Valley Road at 4573 Doe Valley Road. You must bring everything you need for the weekend, as there are no services close by.
